The **Academic Research and Teaching License** for Athena Visual Studio applies to a **Single Named Professor** and his/her research group. The research group comprises of graduate and undergraduate students and postdoctoral students. Visiting scholars may also be granted authorization to use the software for the time of their visit. This license also allows the **Named Professor** to use Athena Visual Studio **FREE of CHARGE** as part of courses in Chemical Engineering and/or related fields. The **Academic Research and Teaching License** is not transferable. Once it is activated, it will be locked to the target computers.

### ► Government Research & Development License:

The **Government Research & Development License** for Athena Visual Studio applies to a **Single Named User** and his/her research group. The research group comprises of other employees, graduate and undergraduate students, and postdoctoral students. Visiting scholars may also be granted authorization to use the software for the time of their visit. The **Government Research License** is not transferable. Once it is activated, it will be locked to the target computers.

### ► Academic Student License:

The **Academic Student License** applies to graduate and undergraduate students attending an Engineering or Science course where the Athena Visual Studio software package is used as part of the instruction process. The **Academic Student License** is offered **FREE of CHARGE** and it requires the Lecturer, Instructor or Professor administering the course to purchase the **Academic Research and Teaching License**. The **Academic Student License** is valid for 365 days.

### ► Individual Commercial License:

The **Individual Commercial License** for Athena Visual Studio applies to a **Single Named User**. The software can be installed on one or two stand-alone computers (for example: home and work, or laptop and desktop), provided that it is only utilized by the **Named User**. The **Individual Commercial License** is not transferable. Once it is activated, it will be locked to the target computers.

### ► Corporate Commercial License:

The **Corporate Commercial License** for Athena Visual Studio applies to all users working for the **Named Corporation** that is purchasing the license. The software can be installed on any number of computers or workstations belonging to the **Named Corporation**.
