## A. Licensing Options

### ■ ACADEMIC SINGLE-USER LICENSE

The **Academic Single-User License** is not transferable. Once it is activated, it will be locked to the target computer. The License is available for annual use only. It provides the end-user the right to use the software [**AthenaVisual Plus**] for a 12-month period. Selected Software Maintenance Services are also included in the License fee [See details below]. The License maybe renewed prior to the conclusion of the License term. Otherwise the License and the Software Maintenance Services Agreement will expire at the end of the 12-month period.

### ■ ACADEMIC MULTI-USER LICENSE

The **Academic Multi-User License** is intended for use by a **Single Named Professor or Researcher** and his/her research group. The research group comprises of graduate and undergraduate students. Postdoctoral students and Visiting scholars may also be granted authorization to use the software for the time of their visit, at the discretion of AthenaVisual, Inc. This License also allows the **Named Professor** to use **AthenaVisual Plus FREE of CHARGE** as part of a course in Chemical Engineering or related field. Graduate and undergraduate students attending the course may use the software for completion of course assignments. The License is available for annual use only.
